William L. Thomas Jr. Mentoring Award Marylu K. McEwen

So what about that big pink chair?! Over the years many graduates at Eighth Vector comment on the metaphor of Marylu's pink chair as symbol of her caring and developmental advising. On March 2, 2010 at the Preview Program Professional Seminar, Marylu was awarded the William L. "Bud" Thomas Jr. 2010 Mentoring Award for her remarkable mentoring of legions of CSP students over decades.



The award was accompanied by such comments as "One of the most formative, significant, and rewarding relationships of my life"; "She has the unique ability of helping individuals draw out their strengths and inner resources"; she "extends a caring heart to those with whom she

interacts"; "She effectively and graciously challenges her students to think differently and more complexly about what they think they know, and supports them in the journey"; "she has 'profoundly affected the lives, knowledge and professional character' of students an alumni; "She is incredibly generous with her time and talent—all the while modeling and living the values of respect and inclusion."

Marylu was a CSP faculty member from 1986 until her retirement in 2007. Among many of her awards, she is an ACPA Senior Scholar, a recipient of the NASPA Contribution to Scholarship and Literature Award, and the ACPA Voice of Inclusion Medallion. In 2004, Marylu received the University of Maryland's Board of Regents

Thomas Magoon 2010 Distinguished Alumni Award

The 2010 Thomas Magoon Distinguished Alumni Award was presented to Dr. Jairo Fuertes on March 22 at the Maryland reception at ACPA. Dr. Fuertes as a professor of counseling psychology at Fordham University. He has coordinated both the Doctoral Program in Counseling Psychology and the Bilingual School Counseling Program. He has also served for ten years as a part-time Staff Psychologist at the Baruch College Counseling Center.



He is the co-author of three books. The forthcoming *Professional Practice of Counseling Psychology* (New York: Oxford University Press), the 2004 *Planned Group Counseling: An Alternative*

Group Method for Reluctant and Chemically Dependent Clients as well as the 2003 *Multicultural Counseling Competencies: AMCD* (Alexandria, VA: American Counseling Association). He is the author or co-author of over 50 conference papers, 25 refereed research articles, 9 book chapters, and has 8 chapters and articles in review including those with a focus on multicultural counseling. He was named Magis Associate Professor in 2005. The Magis Professor Program is University recognition of outstanding junior and mid-career faculty and was awarded to only 5 faculty at Fordham. In 2005 he received the Outstanding New Scholar Award from the College of Education at the University of Maryland.

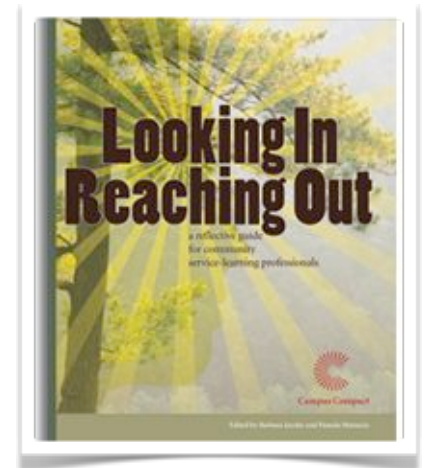
