

Remembering Cynthia S. Johnson

Dr. Cynthia S. Johnson, former faculty member in the CSP program from 1982-1985, passed away after a long illness on January 6, 2011. Dr. Johnson held a bachelor's degree from California State University, Los Angeles and a doctorate from Michigan State University. She also pursued graduate work at Pacific Oak College and the

University of California, Irvine. She held numerous positions in student affairs at Cal State Los Angeles and UCI. She served on the faculties of the University of Maryland and Columbia University and co-founded the program at Cal State Long Beach.

Dr. Johnson was a long-time leader in the American College Personnel Association where she served as its president in 1980-81, and served on the Association's executive council for 9 years. Through her leadership the state division structure was strengthened and under her presidency, ACPA produced it's first statement of ethical standards. Dr. Johnson was awarded the Esther Lloyd-Jones Professional Service Award in 1995, The ACPA Presidential Service Medallion in 2005 and the ACPA Lifetime Achievement Award in 2009. She was also a leading advocate for adult and multicultural students in higher education, calling on the profession to meet the needs of the "new majority" of students. She was a member of the ensemble that developed the Social Change Model of Leadership Development. Dr. Johnson retired from CSULB in 1996. Dr. Johnson loved travel, especially international travel, champagne, and beautiful flowers. A gracious woman, she had a hearty, boisterous laugh that caused all around her to smile and laugh. A memorial service was held January 29 in Laguna Beach. With her friends and former students, we fondly remember Dr. Johnson's significant impact on students and the profession.
