COURSE DESCRIPTION

EDHD 413 is the study of adolescent development, including special problems encountered in contemporary culture. This course will focus on the implications of adolescent developmental theories in contexts of diversity.

COURSE OUTLINE

In this course, we will examine adolescent development from two perspectives. In the first half of the course, we will examine theories about adolescent development. In the second half of the course, we will examine developmental issues (tasks) in adolescence within the family, peer, and school contexts. Throughout the course, we will focus on diversity in adolescence by examining racial, ethnic, and gender differences that may influence the outcome of adolescents' developmental experiences.

COURSE OBJECTIVES

Upon completion of this course, students should be able to:

- Demonstrate a basic understanding of the theories underlying adolescent development
- Identify and describe the nature of contextual influences on adolescence.
- Consider cultural and diversity issues relevant to adolescent development.
- Integrate and connect theories and perspectives of adolescent development to educational practices.

COURSE FORMAT

The format of this course will be a hybrid of face-to-face class meetings on Wednesdays and online (ELMS) class activities typically scheduled on Mondays unless otherwise stated in the Course Schedule. Generally, we will cover the overview of a topic in class followed by further discussion and application online via ELMS.

COURSE REQUIREMENTS

• **Exams* (200 pts)**

There will be **2** non-cumulative exams, each worth 100 points. The format of the exams will consist of multiple choice, true/false, and short response questions covering course materials from readings, lectures, class videos, and discussions.

• **E-Activities (130 points)**

On our online sessions, students will post discussion responses to a particular set of questions to an activity or reading related to the course topic listed for that date. The purpose of these online activities will be to synthesize understanding of topic with other resources and engage in discussion about perspectives with other classmates. Postings will be due by 11:59pm on the assigned date. Each E-activity (EA) is worth 10 points. More details will be discussed in class.

- **Autobiographical Reflection Papers* (80 pts)**

Students will write 2 autobiographical papers, worth 40 points each. The first paper will require a review and application of one of the *theoretical perspectives* of adolescence covered in the first part of the course to your own adolescent development. The second paper will require the review and application of a *developmental task* covered in the second part of the course to your own adolescent development. More details will be provided in class.

- **In-Class Activities (50 pts)**

There will be 10 unannounced in-class assignments, each worth 5 points. These may include reading quizzes, discussion questions, written assignments, group work, etc. on the assigned readings for that particular class.

- **Group Presentation* (40 pts)**

In groups of 5, students will create an online presentation on one of the topics listed in the course schedule beginning on October 1st. These presentations are intended to connect course topics to current adolescent issues in today's culture and will be incorporated into the corresponding E-Activity. More details will be provided in class.

- **Extra Credit (up to 10 pts)**

Opportunities for extra credit points will be provided through quizzes and exams. Students may earn up to a total of 10 points, which will go towards their final grade point accumulation.

Late assignments will automatically drop **1** full letter grade for each **day** the paper is turned in late. Students submitting late assignments must submit a hard copy to my mailbox, located in 3304 Benjamin Bldg (EDHD). You must ask the receptionist for a date/time stamp for your paper to document when you submitted your paper, before placement in my mailbox. Please **do not** submit papers to my office. Likewise, students are expected to take **exams** on the assigned dates and times of the exam. Missed exams will result in zero credit for the exam.

Late Assignments and Make-up exams **will be considered** if students give **prior notice of absence** and **provide required documentation for excused absences** as outlined in the undergraduate catalog. Please see below for specific guidelines for missed classes and grading events. Students claiming an excused absence must notify me as soon as possible via email and furnish proper documentation supporting their absence. *Make-up exams must be taken within 1 week of the original exam date.*

1. Missed single class due to illness: Once during a semester, a student's self-authored note will be accepted as an excuse for missing a minor scheduled grading event in a single class session if the note documents the date of the illness, acknowledgement from the student that information provided in the note is correct, and a statement that the student understands that providing false information is a violation of the Code of Student Conduct. Students are expected to attempt to inform the instructor of the illness prior to the date of the missed class.

2. Major scheduled grading events: Major Scheduled Grading Events (MSGE) are indicated on the syllabus with an asterisk. The conditions for accepting a self-signed note **do not apply** to these events. Written, signed documentation by a health care professional, or other professional in the case of non-medical reasons (see below) of a University-approved excuse for the student's absence must be supplied. This documentation must include verification of treatment dates and the time period for which the student was unable to meet course requirements. Providers should not include diagnostic information. Without this documentation, opportunities to make up missed assignments or assessments will not be provided.

3. Non-consecutive, medically necessitated absences from multiple class sessions: Students who throughout the semester miss multiple, non-consecutive class sessions due to medical problems must provide written documentation from a health care professional that their attendance on those days was prohibited for medical reasons.

4. Non-medical excused absences: According to University policy, non-medical excused absences for missed assignments or assessments may include illness of a dependent, religious observance, involvement in University activities at the request of University officials, or circumstances that are beyond the control of the student. Students asking for excused absence for any of those reasons must also supply appropriate written documentation of the cause and make every attempt to inform the instructor prior to the date of the missed class.
